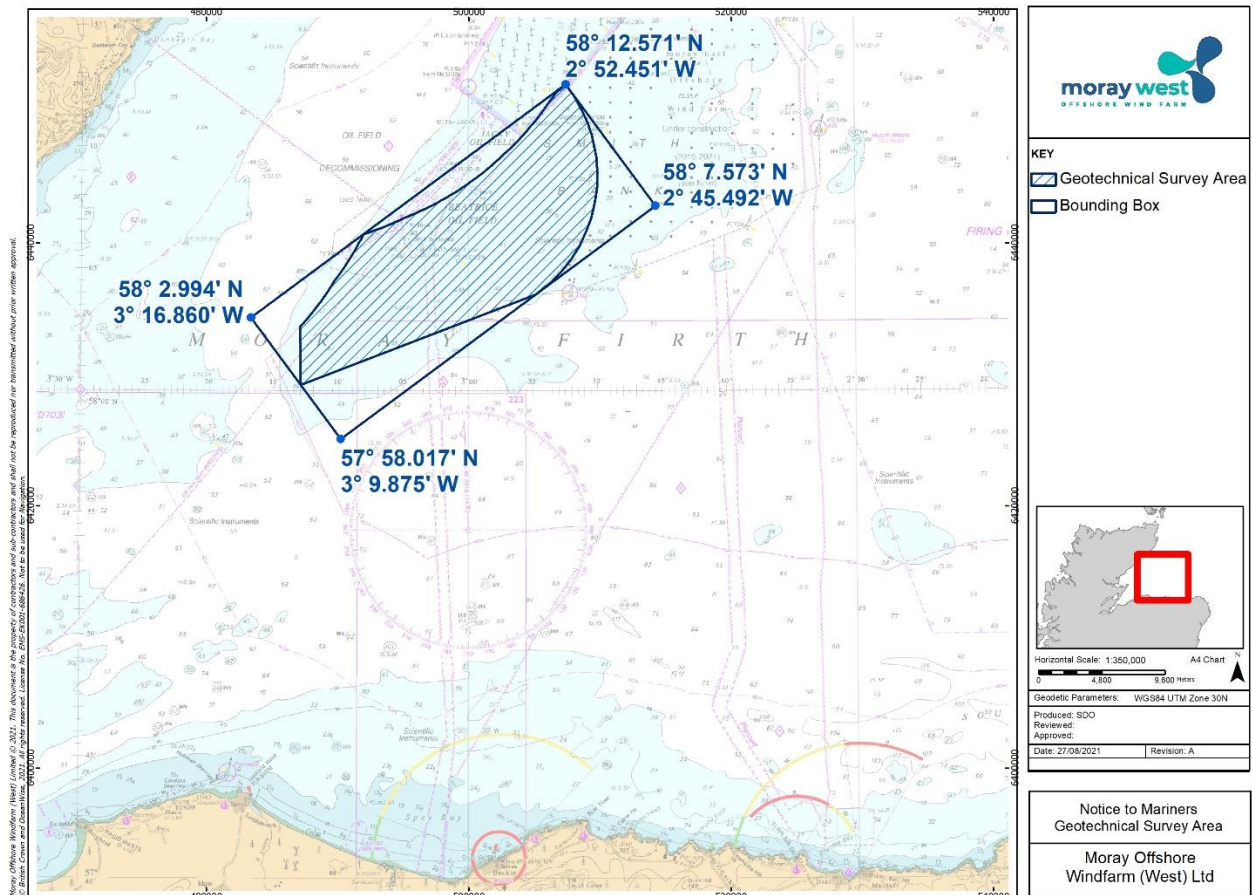

1. Introduction

This notice to mariners is to inform that Moray Offshore Windfarm (West) Limited (Moray West) will be carrying out geotechnical site investigations at the Moray West Offshore Wind Farm Site.

The Moray West site is located on the Smith Bank in the Outer Moray Firth, approximately 22.5km from the Caithness coastline. The offshore wind farm site covers an area of approximately 225km² (Figure 1.)

Geotechnical operations within the wind farm site are anticipated to commence on, and no earlier than, 5th September 2021, and survey duration is expected to be approximately 4 weeks. Geotechnical surveys are forecasted to be completed by 2nd October 2021, but the exact survey duration and completion date will depend on weather and progress of the works

2. Site Investigation works

Scope of work to include:

- Offshore geotechnical drilling and downhole testing at 17 locations (CPT and Seismic CPT).

The coordinates of the geotechnical survey area are presented in the below Table 1.

3. Vessel Information

Geotechnical operations will be carried out by the survey vessel Normand Flower within the Moray West wind farm site with works expected to commence on, and no earlier than 5th September 2021.

Normand Flower will be deploying downhole equipment which will require to remain stationary for periods up to 24 hours at a time. It is requested that all vessels operating within the area keep their distance (at least 500m) and pass at minimum speed to reduce vessel wash.
