
1. Introduction

This notice to mariners is to inform that Moray Offshore Windfarm (West) Limited (Moray West) will continue carrying out confirmed unexploded ordnance (cUXO) disposal works from a vessel at the Moray West Offshore Wind Farm site and Export Cable Corridor (excluding Nearshore area).

The Moray West site is located on the Smith Bank in the Outer Moray Firth, approximately 22.5km from the Caithness coastline. The offshore wind farm site covers an area of approximately 225km2. The offshore wind farm site is given in figure 1.

The vessel works are to take place within the blue boundary shown in the figure above.

The vessel is expected to arrive on site on 14 April 2023, with UXO disposal works anticipated to commence no earlier than 15 April 2023, and work duration is expected to be approximately 16 weeks.

2. Offshore Works - Offshore Confirmed UXO (cUXO) Disposal Works

Scope of work will be to dispose confirmed UXO targets using a technique called deflagration.




Figure 2. Moray West Wind Farm Site. Location of cUXOs to be next disposed of.
