Please be advised that Moray Offshore Windfarm (West) Limited (Moray West) will have a survey vessel working in the Moray West Offshore Wind Farm Site for approximately 3 weeks, excluding weather downtime. The table and figure below provide details of the survey location.

The Geoquip Speer vessel is due to commence a geotechnical survey within the Moray West Offshore Wind Farm Site on the 10th October 2019. This will involve 24-hour continuous operations.

Please be aware that by virtue of its mode of operation and the equipment deployed, the vessel will be Restricted in its Ability to Manoeuvre as defined under COLREGS (International Regulations for Preventing Collisions at Sea 1972, Rule 3). Masters of vessels are therefore requested to maintain their vessels and gears at a minimum safe distance from the Geoquip Speer of 500 metres when it is undertaking its work and showing the appropriate shapes and lights.

In order to not compromise the safety of the Geoquip Speer, its crew, and its ability to undertake its contracted works, fishermen who have static fishing gears deployed within the defined survey area are requested to provide the coordinates of such deployed gears and details of whether the surface markers used are visible at all states of visibility (Section 58 of the Merchant Shipping Act 1995) to David O’Sullivan using the below contact information.




Figure 1: Location of the works.
