

## NOTICE TO MARINERS

Please be advised that Moray Offshore Windfarm (West) Limited (Moray West) contracted EOLOS Floating Lidar Solutions S.L. to install and operate a Floating LiDAR Buoy and mooring system (clump weight and mooring chain) at the Moray West Offshore Wind Farm Site. As part of maintenance activities, the Floating LiDAR Buoy will undergo a maintenance operation. This operation is planned for 30<sup>th</sup>/31<sup>st</sup> December 2019, dependent on weather and scheduled to last up to one day.




Figure 1: Location of the works.

The coordinates of the maintenance operation are the location of the Floating LiDAR Buoy as presented in the below table and illustrated in Figure 1.

Please be aware that by virtue of its mode of operation and the activities involved, the Voe Jarl vessel will be Restricted in its Ability to Manoeuvre as defined under COLREGS (International Regulations for Preventing Collisions at Sea 1972, Rule 3). Masters of vessels are therefore requested to maintain their vessels and gears at a minimum safe distance from the Voe Jarl of 500 metres when it is undertaking its work and showing the appropriate shapes and lights.

In order to not compromise the safety of the Voe Jarl, its crew, and its ability to undertake its contracted works, fishermen who have static fishing gears deployed within the defined survey area are requested to provide the coordinates of such deployed gears and details of whether the surface markers used are visible at all states of visibility (Section 58 of the Merchant Shipping Act 1995) to David O’Sullivan using the below contact information.
