1. Introduction

Moray Offshore Windfarm (West) Limited (Moray West) has contracted Fugro GB Marine Limited (Fugro) to carry out geotechnical site investigations at the Moray West Offshore Wind Farm Site.




Figure 1. Moray West Site. Location of the works

The Moray West site is located on the Smith Bank in the Outer Moray Firth, approximately 22.5km from the Caithness coastline. The offshore wind farm site covers an area of approximately 225km² (Figure 1.)

2. Site Investigation works

Scope of work to include:

- Offshore geotechnical drilling and downhole testing at thirty-two locations (CPT and Seismic CPT).
- Offshore geophysical survey at five locations (MAG, SSS, MBES).

3. Vessel Information

Geotechnical operations will be carried out by the survey vessel Normand Flower within the Moray West wind farm site with works expected to commence on, and no earlier than 26 January 2021.

Normand Flower will be deploying downhole equipment which will require to remain stationary for periods up to 24 hours at a time. It is requested that all vessels operating within the area keep their distance (at least 500m) and pass at minimum speed to reduce vessel wash.

Fugro Galaxy will be towing survey equipment the vessel will require large turning circles therefore it is requested that all vessels operating within this area keep their distance (at least 2000m) and pass at minimum speed to reduce vessel wash.
