1. Introduction

This notice to mariners is to inform that Moray Offshore Windfarm (West) Limited (Moray West) will be carrying out geophysical site investigations at the Moray West Offshore Wind Farm Site and Export Cable Corridor.




Figure 1. Moray West Wind Farm Site and Offshore Export Cable Corridor. Location of the works

The Moray West site is located on the Smith Bank in the Outer Moray Firth, approximately 22.5km from the Caithness coastline. The offshore wind farm site covers an area of approximately 225km² (Figure 1.)

The works are anticipated to commence on, and no earlier than, 4th September 2021, and survey duration is expected to be approximately 6 weeks. Geophysical surveys are forecasted to be completed by 16th October 2021, but the exact survey duration and completion date will depend on weather and progress of the works.

2. Site Investigation – geophysical surveys

Scope of work to include:

• Offshore geophysical surveys will comprise multi beam echo sounder (MBES), single beam echo sounder (SBES), side scan sonar (SSS) sub bottom profiler (SBP) and magnetometer.

The coordinates of the geophysical survey area are presented in the below Table 1.

3. Vessel Information

Geophysical operations will be carried out by the survey vessel Northern Franklin within the Moray West wind farm site and export cable corridor with works expected to commence on, and no earlier than 4th September 2021.

Northern Franklin will be towing geophysical equipment which may be up to 400 m behind the vessel. It is requested that all vessels operating within the area keep a safe distance (at least 1000m) and pass at minimum speed to reduce vessel wash.
